Another year has come and gone, and by the looks of it, winter has come early and will keep our highway employees very busy. I enjoy this time of the year, since it allows us to reflect on what was accomplished during the previous year's time.

**Senior Center** – while almost complete, the senior kitchen has been upgraded to include some new cabinets, a more "user" friendly sink, lowered the countertop and reinsulated the rear wall of the building so pipes will no longer freeze. Painting will be completed soon. A goal for 2011 will be to replace the worn carpet and vinyl flooring.

**Parks** – The trail system, which was the result of countless volunteer hours, has been a great success. We partnered with the Whitesboro School System to host their practices and meets while their school underwent construction. We also were the host of an Invitational Run from the schools, which was a huge success, as

well as the 3<sup>rd</sup> Annual Skeleton Run with over 140 participants – great job.

**Highway Garage** – As you are aware, the new highway garage and associated issues dating back to its construction has not been without issues, including improper insulation in the ceilings and walls, inadequate heating design and electrical issues associated with the poor insulation. As of this newsletter, the Town Board has declared the main contractor in default and will seek all remedies available under the law. You will see additional information on this topic in the upcoming year as I work towards getting these issues resolved with the Town Board, as well as trying to decrease the heating costs associated with the above issues.

**Budget** – Once again, as you will see later in this newsletter, there is no General Fund tax. There will be a decrease in the Highway tax as well. The Town Board worked very closely to put forward a very responsible spend-

ing plan based upon the uncertainty of future revenues.

**Services** – Both myself and the Highway Superintendent sit on an Oneida County Committee that is focused on shared/consolidation of services. The main focus of this committee will be to look at and make recommendations as to where not just Deerfield, but other local governments can share and consolidate services to ultimately save the taxpayer money. While we take advantage of state contract pricing where we can, there are many more opportunities to become more efficient.

## LOCAL LAW 2-2010 THE DEERFIELD DOG LAW

### DOG LICENSING IN 2011

Effective January 1, 2011, the New York State Department of Agriculture & Markets has eliminated the statewide dog licensing program, delegating the authority for dog licensing to each municipality. As such, the Town of Deerfield is now responsible for issuing dog licenses for all pet dogs harbored in the town.

The town enacted Local Law # 2 of 2010 entitled "Town of Deerfield Dog Control Law" effective January 1, 2011. This local law can be found in its entirety on the town's web site, [www.townofdeerfield.org](http://www.townofdeerfield.org)

The town clerk's office will be sending "Notice of Renewal" letters, generated by a revised town wide dog license data base, to owners of dogs harbored in the town. Owners will be asked to review the information on the renewal notice, make necessary corrections and return it, with appropriate fees, to the town clerk's office.

As established in the town dog control law, annual fees for licensing dogs are as follows.

For each spayed or neutered dog: Seven dollars (\$7.00), which includes the assessment of a statutory one dollar (\$1.00) surcharge for the purpose of carrying out animal population control.

For each unspayed or unneutered dog: Fifteen dollars (\$15.00), which includes the assessment of a statutory three dollar (\$3.00) surcharge for the purpose of carrying out animal population control.

Replacement ID Tags: Three dollars (\$3.00).

Enumeration fee: When the Town Board determines the need for a dog enumeration, a fee of Twenty-Five dollars (\$25.00) shall be assessed, in addition to the dog license fees, to all dogs found to be unlicensed or not renewed at the time the enumeration is conducted.

For each Purebred License: 1 -10 dogs - Thirty-five dollars (\$35.00) plus six dollars (\$6.00) per dog; 11-25 dogs - Seventy-five dollars (\$75.00) plus six dollars (\$6.00) per dog; 26 or more dogs - One hundred fifty dollars (\$150.00) plus six dollars (\$6.00) per dog, which individual assessment includes a statutory surcharge of three dollars (\$3.00) for the purpose of carrying out animal control.

For each dog licensed the applicant must provide a copy of the dog's current rabies vaccination certificate issued by a licensed veterinarian. In the case of a spayed or neutered dog, every applicant must also provide a certificate signed by a licensed veterinarian showing that the dog has been spayed or neutered, unless such certificate is already on file with the Town Clerk.

Please go to the town's web site to view the Town of Deerfield Dog Control Law. You may also call the town clerk's office at 724-0413, ext.23 if you have questions.



### **REMEMBER**

Dogs must be on a leash at ALL TIMES or confined to the owners property.  
DO NOT let your dog defecate or cause damage to other property.  
DO NOT allow your dog to bark, whine or howl excessively while outdoors.

### PUBLIC NOTICE

**NOTICE IS HEREBY GIVEN**, that pursuant to Article 7, Section 122 of the State Agriculture & Markets Law, which became effective January 1, 1980, and by a Resolution that was passed by the Oneida County Board of Legislators at their meeting of December 29, 2010, directing that in order to prevent deer depredation in Oneida County, all dogs in the County of Oneida are to be securely confined during a period of time beginning 24 hours after publication of this notice that will be printed in both official County newspapers; the Rome Daily Sentinel on January 3rd and the Utica Observer Dispatch on January 4th, 2011 and continuing until April 15, 2011.

### WHITESBORO CENTRAL SCHOOL DISTRICT KINDERGARTEN REGISTRATION:

Whitesboro Central School District's Kindergarten Registration for the 2011-2012 school year will be held from 9AM-1:30PM and 2-5:30PM:

To be eligible to enter kindergarten in September 2011, a child must be 5 years of age on or before December 1, 2011 and must reside in the Whitesboro Central School District. Proof of age (birth certificate), residency (i.e. National Grid or telephone bill, rental receipt/agreement, etc.) and immunization records must be presented at the time of registration. ## IMPORTANT-ASSESSMENT INFORMATION

### Dear Residents,

Exemption season will be arriving soon. The application and renewal time for exemptions is January 1<sup>st</sup> to March 1<sup>st</sup>. Please take the time to read each section and see what applies to you.

### EXEMPTION RENEWAL INFORMATION

There are three exemptions in particular that need renewal during the first two months of 2011. They are the Senior Exemption, the Enhanced STAR Exemption, and the Agricultural Exemption. If you currently receive one of these exemptions you will be receiving a renewal form from this office around January 1<sup>st</sup>. Please fill it out and return it to the Assessors' Office at the Deerfield Town Building, 6329 Walker Road, Utica, New York 13502, by March 1, 2011.

### ENHANCED STAR EXEMPTION INFORMATION

First the Enhanced STAR exemption. There has been a slight change in the qualification criteria for the Enhanced STAR Exemption. To qualify for this exemption you must be 65 years of age by December 31<sup>st</sup> 2011 and your 2009 federal adjusted gross income must now be less than \$79,050. This exemption must be renewed annu-



ally if you have not enrolled in the income verification program. If you currently receive the Enhanced STAR Exemption you will be mailed the renewal form or an income verification post card during the first week in January. If you receive an income verification post card (which is a small green mailer) you only need to report back to the assessors' office if changes in your residency occur. If you receive a renewal form, return the completed form along with a copy of page one of your 2009 federal income tax return no later than March 1, 2011 to the Assessors' Office at the Deerfield Town building, 6329 Walker Road, Utica N. Y. 13502. An important note to those who receive the Senior Exemption - you automatically get the Enhanced STAR Exemption when you renew your senior exemption. Note if you don't file income tax, please contact our office for a special worksheet to list your income.

### BASIC STAR EXEMPTION INFORMATION

Second the Basic STAR Exemption. This is available to all owner occupied residences in the Town of Deerfield. There is no income constraint for this exemption. There is no renewal process for this exemption, you file for it once and continue to receive it annually.

### SENIOR EXEMPTION

Like the Enhanced STAR Exemption, a renewal form will be sent to those already receiving the Senior Exemption during the first week in January. This exemption potentially gives tax relief for School, Town, and County taxes for those over 65 years of age by March 1, 2011. The amount of the exemption varies drastically based upon the 2010 owner income. The income figure includes all Social Security benefits and income from stocks, bonds, bank interest, etc.

Beginning November 2nd, office hours are Tuesday nights from 6:30–9:00pm or by appointment. Please stop in or call during these office hours (phone: 724-0413 ext. 21).

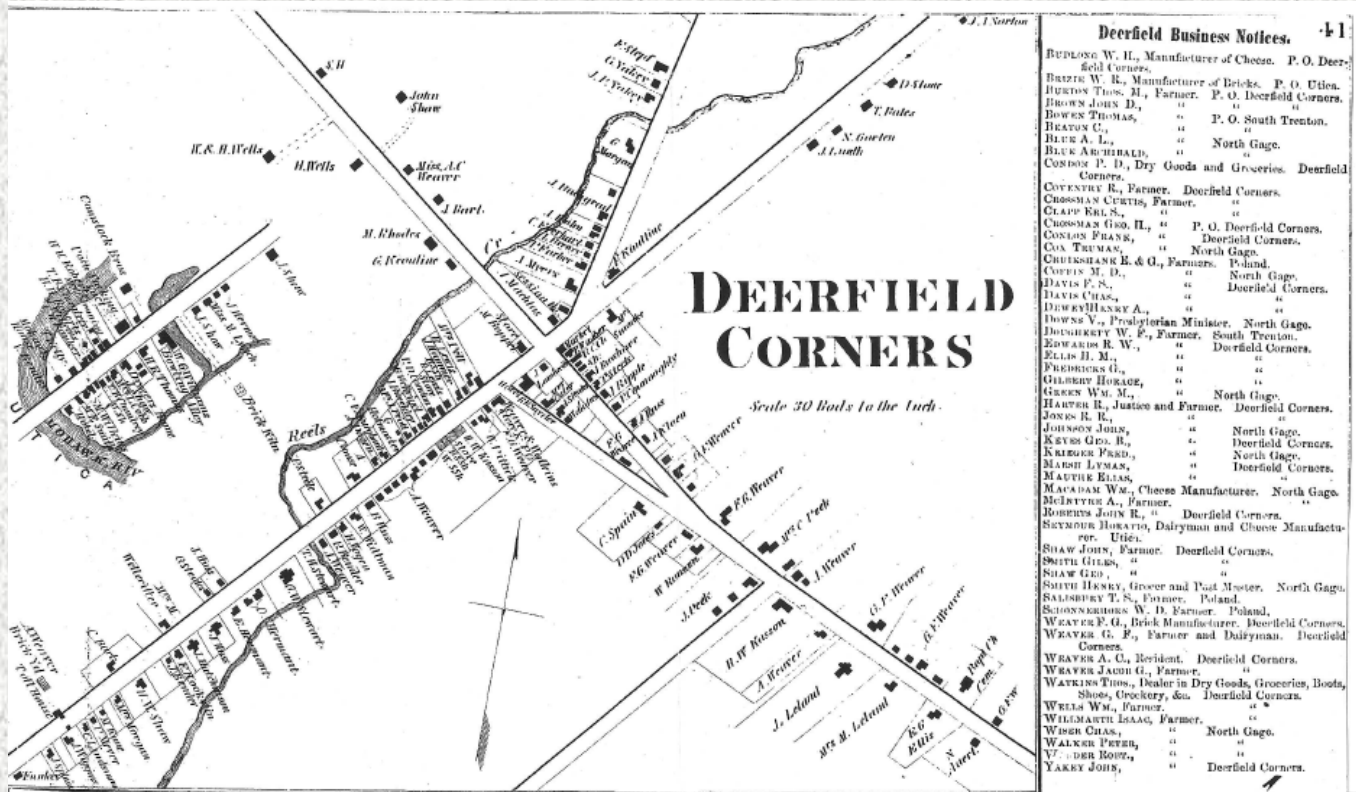

## Town Historian News

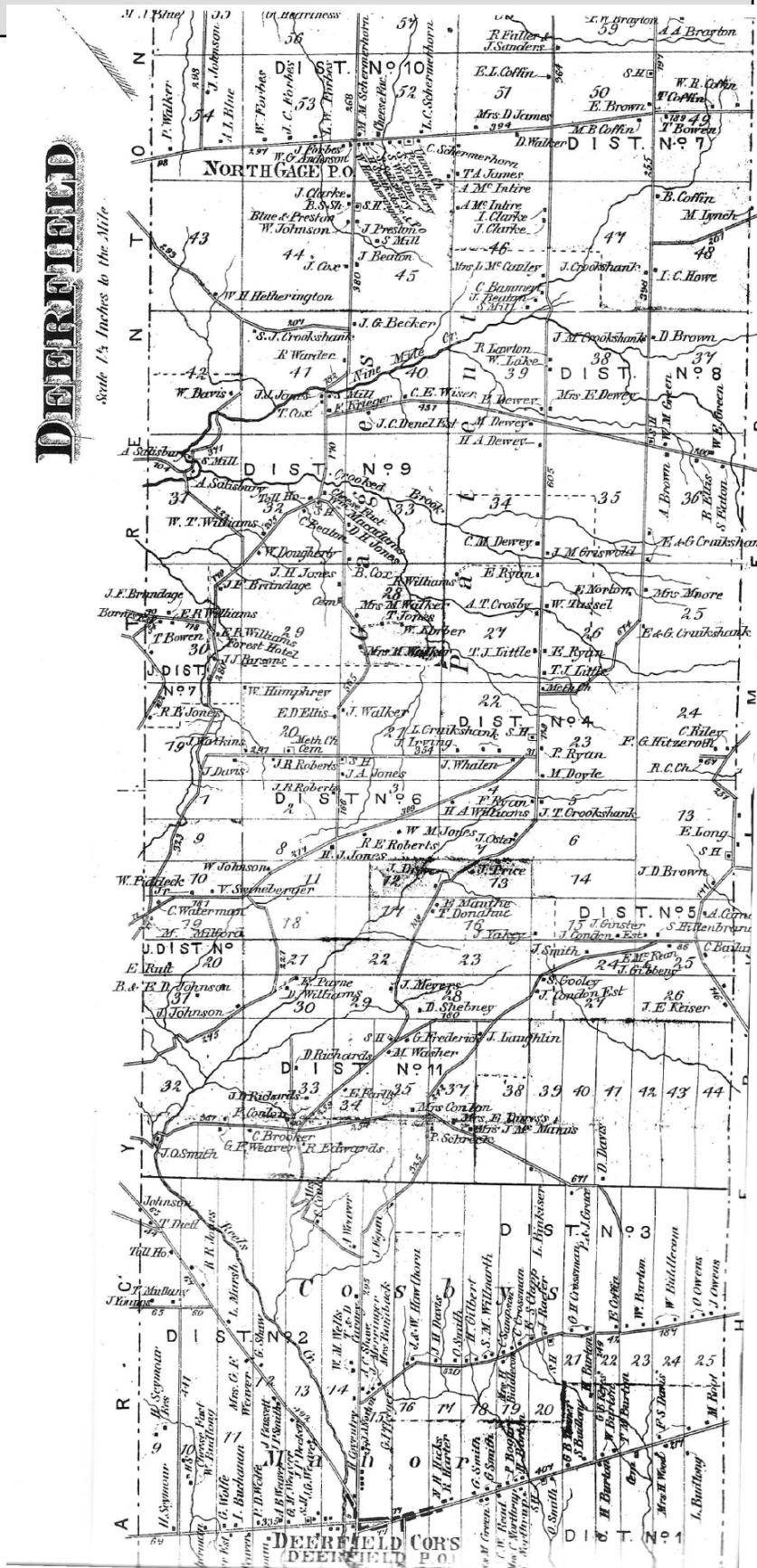
