## A MESSAGE FROM THE SUPERVISOR

This past year has been one filled with challenges, particularly dealing with solar. As many of you are aware, a committee was put together to recommend a local law to deal with future solar applications up to 25 megawatts. They have been working non-stop putting a strong document together. We have conducted two (2) public hearings and will/have conducted a third on 9/26/22. I mention up to 25 megawatts since the State of New York takes away local control on projects greater than 25 megawatts, which we will continue to fight against. I want to personally thank the committee for literally putting in hundreds of hours to date. Your voices and input have been heard and many of the recommendations have been incorporated in the proposed law – Thank You!

The town is exploring developing a drive thru recycling center to be located where our old highway garage is currently. The plan would be to demolish the old garage and build a center for residents to dispose of unwanted items. More information to come on this project.

We are in the process of getting the Parks Committee back in action. Ms. Deborah Burke generously stepped forward to lead the charge. If you are interested in sitting on the Parks Committee, please contact me either by phone or email and I will sure that Deb gets your information.

As a continued update, a reminder that motorized vehicles (4-wheelers and dirt bikes) are not allowed on town property/trails. As are well aware, there is a local law prohibiting this activity on the trails. If you are caught on the trails with a motorized vehicle, the Town will pursue all legal remedies.

In closing, take time to enjoy the resources the town offers as well as attend a board meeting. Your thoughts and opinions matter to us.

# A MESSAGE FROM YOUR HIGHWAY DEPARTMENT



As I am writing this it is hard to believe summer is over and fall is here. The highway department

hopes everyone is healthy and had a fun filled summer. With our weather changing so fast the highway department is still working on the large road project for 2022 hoping to pave in a few weeks. We are starting to gear up for the winter months ahead, bringing in the materials we will need to clear the roads. A reminder school is open now please be careful as are children our out waiting for the busses to pick them up.

As the cooler weather arrives, we still have two green waste dates left in 2022, October 3 and November 7 if the weather permits. As we are out collecting green waste, we are still seeing green waste piled to the curb loose. The highway department does not pick up loose green waste piled at the curb, green waste needs to be put in a reusable container to be collected with a compactor. Brush (tree limbs 1" and larger) shall be piled at the curb butt ends facing the same direction to be chipped by a separate crew.

As in the past Deerfield town residents can bring household trash items to the town garage to dispose of. The highway department asks that you call ahead to make an appointment to use the dumpsters. The town collects electronics for recycling at our facility; we also collect items with a coolant in them such as refrigerator,

freezer, air-conditioner, and dehumidifier. Items we do not accept are **waste oil, batteries, hazardous chemicals, Liquid paint, tires, and fluorescent bulbs**. The town will be having one more Saturday trash collection on October 22 at the highway garage at 6892 State route 8.

As snowy weather gets closer, we would like to remind everyone, please do not plow snow across the road it could cause an accident.

One of the things we have not talked about in a while is the DEC/EPA sewer consent order that must be completed by December 31, 2022. The highway Superintendent went to a county meeting on August 11, 2022 to discuss the things that remain a problem in the system. One of the things that we discussed was the water infiltration in the system after a rain event. The engineers think this is coming from private property owners in the town; some of the things that could cause this problem could be sub-pumps being pumped into the system or rain gutters dumping into the sanitary sewer system. The town has applied for some grant money to find out where the problems are and help repair them.

### **October:**

**3rd - Green Waste  
22nd - Trash town garage**

### **November:**

**7th - Green waste if weather permits or leaf collection.**

**The November green waste will only happen if weather permits.**

***We will be switching over our equipment for leaf season as soon as possible. Green waste will be collected from a container at the curb to be dumped in a compactor. Brush shall be piled separate for collection by a different crew to be chipped. Limbs shall be no more than 10' long or small enough to be handled by one person.***

## PLANNING BOARD SUMMARY 2022

May: A public hearing was held for the Pine Ridge Estates subdivision. An overview of the project was presented by the developer. Residents were then given the opportunity to ask questions. The project was identified by NYSHPO as requiring an archaeological survey. A motion was made and carried to hold open the record until the survey is completed. On May 27, 2022 Clear Path Energy requests an extension of their Special Use Permit which was approved on June 9, 2021. June: Sue Anacker gave a presentation of the final survey map for the Garrett family subdivision. Representatives of Clear Path Energy were present to answer planning board members questions regarding Clear Path Energy request for an extension of their Special Use Permit. The planning board then instructed the representatives to provide documentation of their current investment and clear evidence that the facility has a reasonable likelihood of commencing construction during the one-year extension period in accordance with Article 17.05B of the Town Zoning Ordinance. A motion was made and carried to table making a decision on the proposed extension of the Special Use Permit until the July 6, 2022 meeting. June 29 Clear Path Energy provides the planning board the documents and financial information that was requested. June 30 The Deerfield Preservation Coalition requests the planning board review SEQR for the Clear Path Energy/Christiano Solar Project Special Use Permit that was approved on June 9, 2021. July: A public hearing is held regarding the Garrett family subdivision, located primarily on Steuben Rd. No one from the public offered comments. The public hearing was closed and a motion was made and carried to approve the subdivision. Representatives from Clear Path Energy answered more questions about their request for an extension of their Special Use Permit. Due to the time of submission of the documentation from Clear Path, a motion was made and carried to postpone a final decision on the extension of the Special Use Permit until the August 3, 2022 planning board meeting. Due

to the time of submission of the request by the Deerfield Preservation Coalition to review SEQR for the Clear Path Energy/Christiano Solar Project, a motion was made and carried to table the review until the August 3, 2022 planning board meeting. August: Pine Ridge Subdivision: A Phase 1 Archaeological survey was received from Timothy J. Abel, PhD and forwarded to town engineer Allan Sweirck for review. Representatives from Clear Path Energy were present for the final decision on their request for an extension of their Special Use Permit issued on June 9, 2021. Final questions and statements were made by the planning board members. A motion was made to approve the extension of the Special Use Permit of June 9, 2021 until June 9, 2023. The motion was carried. Members of the planning board researched the request to re-open SEQR for the Clear Path/ Christiano Solar Project. It was determined that SEQR cannot be re-opened. September: Town engineer Allan Sweirczk gave the planning board an overview of the Archaeological survey completed on the Pine Ridge Estates subdivision. The survey, which consisted of 185 test pits, did not show any results of particular significance. The planning board hopes to have the final approval from NYSHPO shortly. (Received NYSHPO approval September 14, 2022) Attorney David Longoretta representing Heenaben Patel, Chatham, NY: The owners of the property located at 5721 Trenton Rd are considering construction of a convenience store at this location. The property is zoned R-2. Mr Longoretta was advised that to move forward with the project the owners would need to obtain a use variance from the ZBA. Neighborhood residents asked questions which Mr Longoretta answered. The owners will be informed of the residents' concerns and the process to obtain a use variance, if they choose to do so.

## ANIMAL CONTROL

### Common Animal Control Calls

There are many reasons that town residents reach out to animal control. Common calls we receive regard barking dogs, dogs off leash, and assistance with stray dogs & cats. Listed below is some general information regarding these common calls.



**Barking Dog (Noise Complaint)-** A barking dog complaint typically is called in when a person has been affected by a dog barking to the point it is altering their home life (losing sleep, difficulty working from home due to noise, or general disruption). The Town of Deerfield has a Noise Law which includes barking dogs. This is defined as a dog that barks, cries, howls, or makes any other noise continuously and or incessantly for period of 10 minutes or barks intermittently for 30 minutes or more to the disturbance of any person at any time of the day or night. Given this we ask that if your dog is barking for an extended period of time that you please bring your dog inside or modify their situation as to deter the barking and avoid disruption of your neighbor.

**Off Leash-** Off leash dog complaints generally are brought to our attention when a person or pet has been chased, scared, or attacked by a dog that is off leash. Commonly this occurs when residents are walking on the street and a dog comes off the owner's property. The Town of Deerfield has a Leash Law which requires a dog owner to keep their dog on their property. If the dog is off their property running "at large" (off leash) this is a violation of the town's leash law. We encourage you to keep your pet safe and on your property. This not only to protect the residents of the town and their pets but also prevents your dog from being hit by a car or injured.

**Stray dogs/cats-** If you find a stray dog or cat Deerfield Animal Control is here to help. We currently contract with Anita's Stevens Swans Humane Society. If a stray dog or cat is found we are happy to pick up the animal and bring them to the shelter. Once they are at the shelter they will be held for a period of up to 7 days to give an owner time to claim them with proof of ownership such as vet records, photos, dog license or vaccine tags. If they are not claimed after this hold period they become a resident of the shelter and placed for adoption. Anita's Stevens Swan Humane Society is a wonderful shelter that truly cares about the animals. They take excellent care of them until they are adopted into their new forever home.
